### Decision made

Cabinet Members making the decision	Councillor Jonathan Bianco, Deputy Leader of the Council, on behalf of the Leader, in consultation with Councillor Wayne Bridges, Cabinet Member for Community & Environment
Decision	<b>Agreed</b>  The Deputy Leader of the Council, on behalf of the Leader, in consultation with the Cabinet Member for Community & Environment:  1) Accepted the additional grant funding allocation of £700,000 from National Trading Standards to continue the ongoing work at Heathrow Airport to seize and destroy illicit vapes, to also be reported to Cabinet; and  2) Agreed to the Direct Award to WasteCare Ltd for the provision of illegal vapes disposal on behalf of the London Borough of Hillingdon for the period 20 September 2025 to 20 September 2026 and at the cost of £150,000 for that period with all other arrangements remaining as per the existing contractual arrangements.
Reason for decision	The Council has a statutory duty to ensure consumer goods intended for the UK market are safe and comply with relevant legislation. Trading Standards Officers conduct regular checks on imported goods at Heathrow Airport.  Since January 2024, the Council has participated in <b>Operation Joseph</b> , a national initiative targeting the importation and supply of unsafe single-use vape products. These products often fail to meet UK regulations, with issues

	<p>such as excessive nicotine levels, banned ingredients, oversized tanks, and hazardous substances like lead, nickel, and chromium.</p> <p>The Government has committed additional funding to support enforcement agencies, including Trading Standards, Border Force, and HMRC, to tackle illicit trade and enforce laws such as the ban on disposable vapes. New legislation will also restrict vape flavours, introduce plain packaging, and change retail displays to reduce youth appeal.</p> <p>Trading Standards Officers seize and dispose of non-compliant products at the border in line with the Waste Electrical and Electronic Equipment (WEEE) Directive. The Office for Product Safety and Standards (OPSS) oversees recycling standards and has identified approved facilities for safe disposal. WasteCare Ltd is the Council's current supplier of this service and offers good value for money.</p> <p>Since the start of the operation, significant quantities of illicit vapes have been detained at Heathrow Airport. The Council plans to extend its disposal contract to ensure continuity of this work, subject to future funding decisions. Further updates will be provided as the project progresses.</p>
<b>Alternative options considered and rejected</b>	Other Approved Authorised Treatment Facilities ATFs may be available. OPSS is satisfied that the suppliers on their list offer good value for money and have the necessary expertise to dispose of detained goods.
