<b>Decision</b>	<p><b>The Cabinet Member for Planning, Housing &amp; Economic Growth:</b></p> <p><b>1) Noted the responses received to the informal consultation for a possible Parking Management Scheme in Westbourne Close, Hayes; and</b></p> <p><b>2) Decided for the current parking arrangements to remain unchanged in Westbourne Close, Hayes at this present time.</b></p>
