RECOMMENDATION

That the Cabinet Member for Children, Families and Education agrees to the Instrument of Government for Field End Infant School

Reasons for recommendation

The board wish to maintain the existing number of governors (11) but amend the composition of the governing board due the difficulty in recruiting parent governors. The school has recently reduced it's PAN from a 3 from to 2 form entry. The number of Parent governors is to be reduced by one, from three to two. The number of Co-opted governors is to be increased by

one from five to six. This change is intended to strengthen the governing board by enabling it to recruit individuals with specific expertise and skill sets aligned to the current and future needs of the school.

The board will continue to be made up of a total of 11 (eleven) governors, and will consist of:

- 1 Local Authority governor
- 1 Staff governor
- 1 Headteacher
- 2 Parent governors
- 6 Co-opted

Alternative options considered / risk management

Legal

There are no legal implications arising from this report. The governing bodies of local authority-maintained schools must be constituted in accordance with regulation 13 The School Governance (Constitution) (England) Regulations 2012. There is no upper limit on the size of governing bodies, and they may appoint as many co-opted governors as they consider necessary. The number of co-opted governors who are eligible to be elected or appointed as staff governors must not, when counted with the one staff governor and the headteacher, exceed one-third of the total membership of the governing body. There must be a minimum of 2 parent governors. In addition to the requirements imposed by regulation 13 and considered in the preceding section, foundation and voluntary schools are required to have partnership governors. Foundation and Foundation special schools without a foundation must have at least two partnership governors.
